The Township Officials would like to welcome the following individuals to their respected positions: Bob Decker-- Township Supervisor, Amanda McGhee-- Real Estate Tax Collector, Eric Hagan--Zoning Officer, and Summer Smoker-- Auditor. We would like to thank Greg Chiappini for his service as Township Supervisor and Kathy Weber for her many years as Tax Collector. You both will be sorely missed. The Township Officials would also like to extend their condolences to the family of Norman Turner. Norman served as a Township Auditor. The Supervisors would like to express their gratitude for the donation of the school bell, donated by Norman and his family. It is displayed in the front of the Township Building in memory of the one room schools in Wolf Creek Township.

This year the Township plans to place approximately 110,700 Square Yards of Seal Coating on various Township Roads. Young Blood Paving won the bid this year through the Mercer County Joint Seal Coat Program. This program implements and provides cost effective means for Seal Coating Roads within a municipality. Also, included in this year's budget, funds were allocated for road maintenance, including rebuilding portions of Jamison and Creek Roads, along with purchasing materials such as stone, anti-skid and road salt for winter maintenance.

The Township was awarded \$85,933.42 through the American Rescue Plan Act. These funds were distributed due to revenue shortfalls caused by the pandemic. The U.S. Treasury has released a Final Rule that allows a Standard Allowance for Townships, which gives a broader opportunity to use these funds. This includes, roads and bridges, vehicles, equipment, computers, among other general government services. Townships have until December 31, 2024 to obligate these funds.

- **September 23, 24, and 26 from 9-10 AM and September 22, 27, and 28 from 6-7 PM**

These dates and times will be listed on your tax bill.

You may also pay your bill by mail to: Amanda McGhee, Wolf Creek Township Tax Collector, 218 Elliott Road, Grove City, PA, 16127. Mail in payments must be received or postmarked by the due date. If a receipt is needed please include a self-addressed stamped envelope or you can provide and email address and a receipt can be sent via email (the email address must be legible). You can also schedule an appointment for in person drop off at my house at 724-866-2873.

All payments should be made to: Wolf Creek Township Tax Collector.

As a reminder:

- 1) When demolishing a structure the county needs to be notified so they can update the real estate taxes. Real estate taxes will be billed on the structure until the county is notified.
- 2) Mobile home removal permits can be obtained from the Tax Collector.
- 3) If you are moving out of the Township or know of someone moving into the Township, please contact the Tax Collector so the per capita records can be updated.
